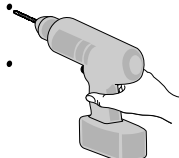
If, after consulting with appropriate local engineering, architectural, or construction personnel it is determined that wall anchor hardware should be used, refer to the following instructions.

4. Push collar into hole.
5. Snap off loop.

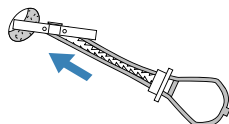
