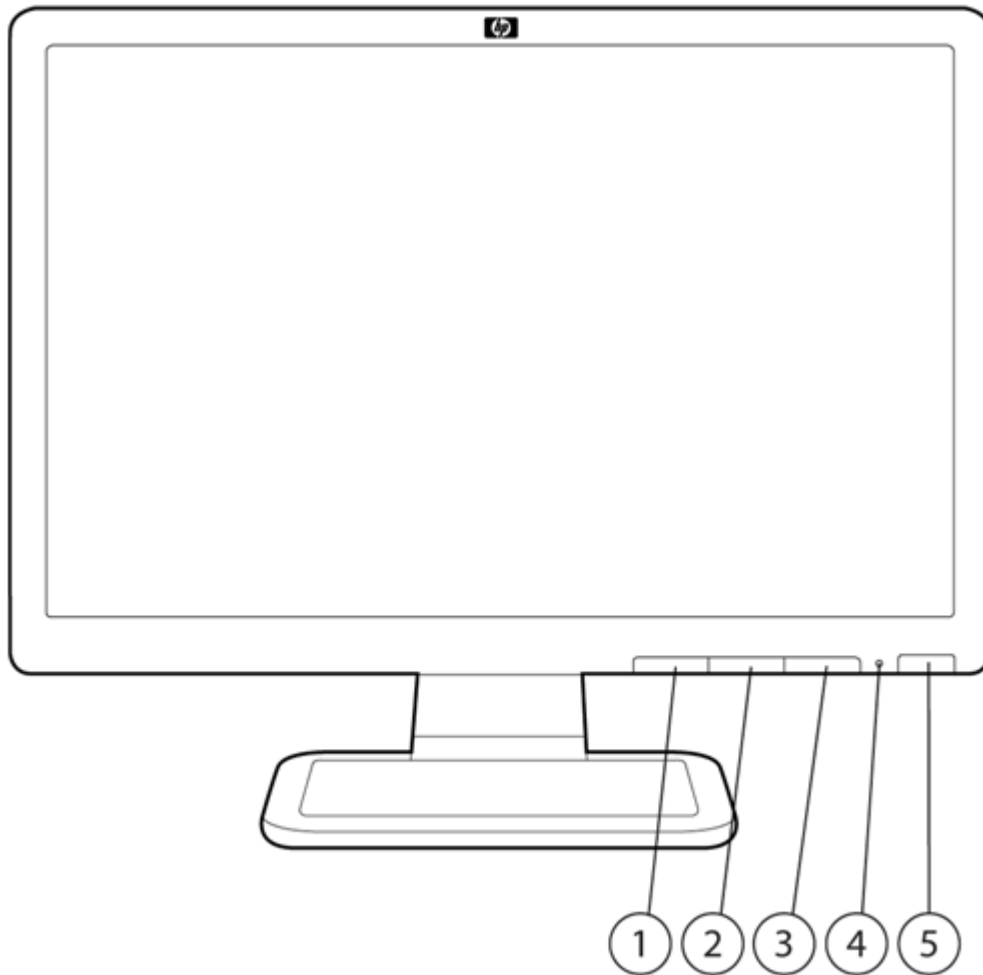


### Overview



- 1. Menu/select:** Opens, selects or exits the OSD menu.
- 2. "-" / Auto:** Navigates backward through the OSD menu and decreases adjustment levels; when the OSD menu is inactive, activates the auto adjustment feature to optimize the screen image.
- 3. "+":** Navigates forward through the OSD menu and increases adjustment levels.
- 4. Power LED:** fully powered = green; sleep mode = amber; sleep timer mode = flashing amber.
- 5. Power:** Turns the monitor on or off.
